# 5 Legal basis for data processing

According to Art. 13 para. 1 lit. c) GDPR, we must also inform you about the legal basis for data processing on our website and the purposes of the respective data processing. Data processing on our website is permitted on the following legal bases:

### 9 Duration of storage of the personal data

### 10 Right of withdrawal

The declaration of consent can be revoked at any time without giving reasons and without any personal disadvantages. The revocation applies with effect for the future. ### 11 Rights of data subjects

According to the General Data Protection Regulation, you have the following rights:

- If your personal data is processed, you have the right to obtain information about the personal data stored about you. If necessary, you must specify which information or which processing operations your request for information relates to. (Art. 15 GDPR in conjunction with § 12 DSG NRW)
- 2. If incorrect personal data is processed, you have the right to rectification. (Art. 16 GDPR)
- 3. If the legal requirements are met, you can request deletion, taking into account § 10 DSG NRW. (Art. 17 GDPR)
- 4. If the legal requirements are met, you can request the restriction of the processing of the data concerning you (Art. 18 GDPR)
- If you have consented to the data processing or a contract for data processing exists and the data processing is carried out using automated procedures, you may have a right to data portability.

(Art. 20 GDPR)

6. The data subject shall have the right to object, on grounds relating to his or her particular situation, at any time to processing of personal data concerning him or her which is based on point (e) or (f) of Article 6(1).
